Explanatory Note

This Amendment No. 2 (the "<u>Amendment No. 2</u>") is filed by Skorpios Trust, Montrago Trustees Limited ("<u>Montrago Trustees</u>"), Ezbon International Limited ("<u>Ezbon</u>") and Blue Horizon Enterprise Ltd.
